Dawn F., Co-Chair, gave a brief report and submitted a written report for August. The Committee met on August 19 via Zoom, with 4 members present. All in-person commitments except the Driver Intervention Program are on hold due to COVID. Committee members have fulfilled all DIP commitments. For DIP's, only 4 AA's can participate due to social distancing; the Committee plans on 1 Committee member and 3 Home Group members to attend each commitment. If a group cannot fulfill their committee members may attend. To find the group call the Committee Chair to inform them ahead of time, so that more Committee members may attend. The Lucas County Jail has no means of utilizing DVD's or CD's. On August 12, the Committee took a box of literature, books, and newsletters to the jail. CTF Men's facility may have the ability to do Zoom meetings – they are discussing internally and will get back with the Committee. The CTF Women's facility currently provides Central Office directories upon discharge. Currently, the work release programs (men's and women's) at CTF does not have any inmates. TCI (prison) received 5 different DVD's from the Committee on July 31. TCI has the ability to play the DVD's on an inmate channel for viewing inside each cell. Allen-Oakwood Correctional Institution (AOCI) in Lima is checking into what platform they can use to conduct online meetings. An AOCI inmate seeking a sponsor was connected to the Committee.

The Committee has also been invited to attend weekly International meetings related to corrections committee work. This meeting is held on Zoom, the first and last Sunday at 6 p.m., and the in-between Sundays at 11 a.m., meeting ID 239-990-5603, password 765110.

Mini-Conference Planning Committee: A conference planning committee needs to be formed for the March 5-6, 2021 Area 55 Mini-Conference. If you are interested in joining that planning committee, please contact Jim.

Ohio State Convention/East Central Regional Conference: Jim discussed the potential cancelation of the 2021 Ohio State Convention and the East Central Regional Conference, in which Area 55 is scheduled to host in August 2021. There are likely cancelation charges, but those can be minimized the earlier we choose to cancel. Jim is asking the conscience of the Area on how to proceed.

2021 General Service Conference: This has been scheduled to take place online again (not in-person in New York), and will be a longer conference than the abbreviated 2020 GSC.

General Service Office update: General Service Office has canceled all 2021 Regional Forums. Also, Box 459 and the Quarterly Report will not be mailed out in the next few months – they will be e-mailed. GSO has also unveiled a new literature website.

Sherry S., Area Chair/Alternate Delegate, mentioned that we will see what guidance the General Service Office has regarding this.
