Multi-District Correctional: Dawn and Geno F / corrections.chair@area55aa.org/

, Committee Co-Chair, gave a verbal report and submitted a written report. The Committee met on October 20, 2021 at Central Office, with 20 members present (including 11 new members). The Committee met 2 out of 2 Driver Intervention Program commitments, however the groups assigned by Central Office did not meet either of the two commitments. The Committee met with the Intergroup Central Office Committee to discuss assigning and will work with them to make sure groups are aware of their commitment. The group commitments for the DIP program for the remainder of 2021 are posted at area55aa.org. The Lucas County Corrections Center (Jail) contacted the committee September 24 to request inperson meetings (3 for men and 2 for women). The committee currently has 18 members that were approved in early 2020, but 13 of those are no longer active with the Committee. Since September 24, 14 additional Committee members were approved, making the total members approved for the jail at 19 total. The women's meetings at the jail will be Thursdays at 7 p.m. and Saturdays at noon. The men's jail meetings will be Mondays at 7 p.m., Thursdays at 8 p.m., and Fridays at 3:30 p.m. For CTF-Men's Campus, the weekly meetings have increased to 12 men weekly. The Committee needs 3 more members to fill the weekly commitment but are waiting on CTF to provide training. For CTF-Women, there continues to be 25-30 women attending at each weekly meeting. The CTF Women's facility is planning to move to the TCI (prison) campus this year. The Committee still needs two additional members to fill the CTF-Women's weekly commitment. The Committee is also working with TCI (prison) to approve two applications that have been pending since September 1, and seven more applications submitted October 20. The Allen-Oakwood Correctional Institution (AOCI) in Lima has requested AA Committee presence in Zoom meetings held Tuesdays at 5 p.m. and Thursdays at 6:15 p.m. There are ten members of the Committee available for the AOCI meetings. The Wood County jail contacted the Committee requesting assistance in holding 2 men's meetings and 1 women's meeting weekly. The Committee submitted four applications to the Wood County Jail and are pending approval. The Committee decided that members will commit to 4 months of a particular assignment at a facility. The Committee is asking for Assembly approval for 4 Grapevine renewals for CTF men, CTF women, LCCC men and LCCC women and 1 new subscription for the Wood County Jail, all of which total \$144.85.

ASSEMBLY ACTION FROM COMMITTEE REPORT

Connor G , GSR – Came to Believe, moved to approve the request from the Multi-District Corrections Committee for \$144.85 for 4 Grapevine renewals and 1 new Grapevine subscription. After discussion, the Assembly voted. With more than 2/3 in favor, the motion passed, and the Assembly will provide \$144.85 to the Corrections Committee.

- After the vote, a minority opinion was expressed by John C , Past Delegate Area 55 Panel 66.
- After a minority opinion was expressed, two members expressed their interest in changing their vote
- The Assembly proceeded to vote on whether to reconsider the motion. The motion carried.
- The Assembly then re-voted on the motion to provide \$144.85 to the Corrections Committee. With 26 voting yes, and 7 voting no, a 2/3 majority was reached, and the motion passed, and the Committee will provide the Committee with \$144.85.
