DELEGATE'S REPORT: Sherry S / delegate@area55aa.org

Sherry S, Delegate – Area 55 Panel 72, provided the Delegate's Report.

I know you're all anxious to hear my report back to you about the 72nd General Service Conference held in Brooklyn New York. It was spiritual in its nature from the time I responded "Present" to when I listened to the Trustee of CPC/Treatment/Accessibilities give her departing speech saying "Goodbye" after having served Alcoholics Anonymous for six years. The 72nd Conference was well attended. There were 133 voting members present consisting of Class A Trustees; Class B Trustees: Non-Trustee Directors and staff from the General Service Office: as well as Delegates and two Alternate Delegates attending in place of the Delegates from their respective areas. I flew in on Friday April 22nd. I arrived at the hotel and checked in around noon. I turned around from the front desk and standing there, behind me, was the Delegate from Area 56 waiting patiently to check in herself. It was nice to see a friendly face immediately upon my arrival. We arranged to meet after settling into our rooms. We found a local grocery store and bought some snacks and large bottles of water to have in the rooms. We needed to find the nearest pharmacy, close by restaurants, the UPS/FEDEX/POSTAL Service facilities that were nearby, and to get our bearings of the area. We met later for dinner where we ran into some Panel 71 Delegates that had arrived days earlier to enjoy some of New York City before beginning their first in-person conference. The Conference did not begin on Saturday, but there were events scheduled. If you take 12 steps times 12 traditions times 12 concepts you come up with the 1728 meeting held before the Remote Communities meeting. The Pre-Conference Remote Communities Meeting held presentations and round-table discussions. We discussed who these communities are and how to reach them. Many good questions were raised. Does a remote community consist of refugees living in the United States or Canada having arrived from another ethnicity or culture living around the corner in your city? I learned that in Chicago and New Jersey there are remote communities of Polish speaking A.A. members. Or is a remote community someone living in Alaska or Nova Scotia? Maybe the remote community we are familiar with now is the group living in an assisted living facility unable to attend in-person meetings. The focus was directed to what are the challenges and solutions to carrying the A.A. message to a Cultural, Geographic, or Linguistic community. So much to question and consider and that was the pre-conference day! Dinner was served and I moved into a Delegates Only Meeting with a welcome delivered by the Alternate Delegate from Panel, Area 79, British Columbia/Yukon. I was provided with an overview of Conference Week, Orientation Presentations about Service Experience from Panel 71 Delegates, and a presentation regarding Bill W.'s and Dr. Bob's essay, "Your Third Legacy, Will You Accept It?" and the conference had not even started! On Sunday Registration began at 8:00 a.m. There was buzz and excitement in the air. Conference Day One was filled with confusion, remember hardly anyone had participated before. So,

this line for name tags; that line for clickers to vote; and, of course, standing to say "present" as roll call was taken. I felt the spiritual nature of the Conference. The opening session started at 9:00 a.m. with a Welcome from the Chair of the General Service Board, Linda C, an opening, and a roll call.

It was my humble privilege to state "Present" when my name was called. There were Greetings, an Overview of the Agenda/Manual, A Keynote Address and a Workshop packed into the morning session. Then off to an East Regional Luncheon with Cathi C, Trustee and fellow regional members from Wisconsin, Illinois, Indiana, Michigan, and Ohio (Fourteen Delegates total; with some Panel 71's and some Panel 72's). The Sunday afternoon session consisted of going over the mechanics of the conference, presentations, and discussions, a closing of the afternoon session. Beginning at 5:00 p.m. I entered a joint meeting between the Trustees Committee on Cooperation with the Professional Community (CPC)/Treatment/Accessibilities and the Committee bearing the name Treatment /Accessibilities. It felt like an invasion, the room went from nine people to no seats left and 19 people at the table. At 6:30 the day ended with the Opening Dinner. A meeting followed. There was a Chairperson, a Leader and five Speakers ending with the Responsibility Statement at 9:30 p.m. I had survived my first day of the conference! On Monday beginning at 9:00 a.m. we entered Conference Committee Meetings until noon when we broke for lunch. Our committee met with the Professionals retained to assist with the development of military audio clips. Their names? Tom and Jerry, a representative from the United States and a representative from Canada. After lunch, we heard reports from the General Service Board, the A.A.W.S. Board, and the A.A. Grapevine Board. Dinner followed and meetings resumed at 7:00 p.m. We received the Finance Report and there was a general sharing session held-"What's on Your Mind?" While Monday's sessions ended at 9:30 p.m., I still had to review and digest the reports given that day and fill an electronic Conference Evaluation Form. Tuesday started at 9:00 a.m. with Conference Committee Meetings where the Equitable Distribution of Work (EDW) agenda items were discussed at length. All committee members participated and stated their respective viewpoints on the agenda items we were asked as a committee to review. Lunch followed and again the entire Conference met in the Grand Ballroom to hear presentations on "Going Beyond Fear"; "How do A.A.'s go to any lengths to Recover, Unify, and Serve?"; and "How to Reach Anyone, Anywhere." There was also a special Board Presentation "Participation of Online Groups in the US/Canada Service Structure". With a short break in between, there was a presentation on "The Warranties-Our Promise to the Fellowship and the World" and then dinner time. Tuesday evening was a Delegates Dinner and Delegates Only Meeting and the Trustees held a separate dinner meeting. Wow, I'm at Wednesday already! How did that happen? The conference is already halfway over. Little did I know, now the work started. 9:00 a.m. Committee Reports began. Wednesday through Friday we heard thirteen committee reports presented. Agenda, CPC, Literature, and Finance were the first to he heard. There were eleven recommendations from those committees. All recommendations passed that day. Day 2 Public Information, Grapevine/LaVina, Policy and Admissions and Trustees. There were fifteen recommendations from these committees. Fourteen passed and one failed to reach substantial unanimity. The recommendation that failed was returning the last paragraph in the story "Freedom from Bondage" to the next printing of the Big Book. Finally, on Friday Report and Charter, Treatment and Accessibilities, Corrections International Conventions/Regional Forums, and Archives. There were three recommendations passed. Total number of recommendations was thirty-three. Total Passed Recommendations was thirty-two and one Failed. During these three days, two of them started at 8:30 a.m. with Thursday ending at 10:30 p.m. and Friday ending at 11:00 p.m. During the conference there was an outbreak of Covid which hit Delegates, Trustees, and staff. People had to be isolated in their rooms, and committee reports had to be delivered by the Alternate Committee Chairs. Covid Rapid Tests were available as were masks and sanitizers. Everything to keep us safe. Audio was set up so that isolated delegates, trustees, and staff could listen to what was happening on the floor from their rooms. Delegates asked for and received a count of those isolated so that delegates continued to maintain 2/3rds majority voting status. There were nine floor actions presented to the conference members and provided to the Conference Secretary to be heard following the agenda items recommended for action by the various committees. Five floor actions the conference declined to hear, one recommendation passed, and three other recommendations failed. I assure you these were fully debated and discussed and hammered out on the anvils of experience. There are thirteen Committee Chair positions and thirteen Alternate Committee Chair positions. Our Region faired well as Two Committee Chairs and two Alternate Committee Chairs were elected from the East Central Region. I am humbled to tell you I was selected as the Alternate Chair of the Treatment and Accessibilities Committee for the 73rd General Service Conference.
