The next meeting will be June 27, which will also be an emergency meeting of Intergroup officers & committee chairs only. The Pig Roast will not be taking place, as the church is not scheduling any events. The Intergroup Association is still planning on having a picnic later in the summer if possible. The rest of the events are still scheduled, but no action has been taken to the contrary.

At the bonfire, a new member attended with 90 days sobriety – so the committee is still reaching new members. DISTRICT COMMITTEE MEMBER (“DCM”) REPORTS

DCM Chair: Kimbrough Polinsky, District Committee Member Chair

Kimbrough Polinsky gave a brief report. The DCMC meeting was held today at 11:30 a.m. via Zoom with representation from Districts 3, 4, 7, 9, and 14. The Delegate and Alternate Delegate were also in attendance as well as 2 guests. District 3 had a Zoom meeting recently and may be looking into doing a picnic and a workshop. Some districts were reporting that a few meetings were back to in-person. Discussion was held on suggesting that the Area 55 General Service Assembly meet less often (currently once a month) and potentially rotate the locations of the Assembly around the Area to different districts. The Committee is also seeking input about Unity Day – it is unknown whether it will be in-person, via Zoom, or a hybrid combination.

District 7: Bill Gotthart, DCM

Bill reported that Chapter 5 is open and that the following groups are meeting in-person at the club: Swan Creek Noon, Happy Hour at 6 p.m., Monday Night Men's at 8:30 p.m., and Thursday Night Men's at 8:30 p.m. Another face-to-face meeting in District 7 is Monday night Airport Group 12x12 group at Providence Lutheran Church. District 7 is planning on having a Big Book Study meeting start sometime in the fall, and more information will be given at a later time regarding this new meeting.

District 9:

Larry Bischoff, GSR – Sunday Serenity, presented a brief report. The Alano Club in Wauseon is holding every meeting on the club schedule except Sunday Serenity. Other District 9 meetings being held in-person include the Thursday night Together With Faith meeting in Napoleon and the Defiance Sunday Night Lead.

Jim Snider, Panel 70, Area 55 Delegate, and Alternate Chair of the CPC Committee presented the Delegate's Report:

2020 Ohio State Convention: The conference scheduled for August 21-23 in Area 54 has been canceled, and the hotel has given Area 54 a full refund.

2020 International Convention: Starting July 1, www.aa.org will announce a schedule for a month-long Virtual Conference in lieu of the in-person conference. Several activities are planned, including speakers, panels, and the 40 millionth Big Book will be passed out.

Position opening at AAWS: There is a volunteer non-trustee director position open at AA World Service in New York – if anyone is interested in applying, they can contact AAWS.

70th General Service Conference: The 70th AA General Service Conference was held via Zoom May 16-19, with 4 days of activities.

- The Conference is composed of 93 Delegates, 27 Trustees (20%), and 15 AAWS and Grapevine Directors (12%). The average age of the Conference attendees was 59 years, the average length of sobriety was 22 years, and the average length of service was 17 years.
- 2 new Trustees were elected: Mike L. was elected as a West Central Regional Trustee, and Erma V. was elected as a Western Canada Trustee.
- Agenda items: due to the limited conference, only the agenda items that needed pressing attention or selected by each Committee were selected to be discussed at the conference. All other agenda items will be automatically forwarded as agenda items at the 71st General Service Conference in 2021. Only 45 minutes were allotted for debate on each agenda item – after 45 minutes without any action, the item would be forwarded automatically to next year's General Service Conference.
- Items that were passed and/or adopted at the General Service Conference will be posted on the Area 55 website.
- The Theme for the 71st General Service Conference will be "AA in a Time of Change."
- The Topics selected for the 71st General Service Conference will be "Unity in a Changing World," "Service in a Changing World," and "Recovery in a Changing World."
- The Conference debated at length over the selection of a non-trustee director, which did not conform to AA's policy. The position will remain open and a selection will be made at next year's Conference.

AAWS Financial Information: In 2019, contributions were up 5.7% from 2018. There were increased costs in 2019, primarily due to the cost of implementing a service for groups that went over budget. The General Service Office also shut down an office and opened a new combined office, which cost over \$1 million, and now must re-open the closed office due to fire code capacity violations in the new space. During 2020, AAWS was losing over \$1 million per month due to a drastic drop in sales and contributions during the Coronavirus pandemic. However, in May, a record was broken as over \$850,000 was contributed. Sales dropped drastically as well but are slowly starting to trend upward.

Area 55 Groups Re-Opening: Jim asked that groups that are considering re-opening to please inform themselves of all appropriate information, including any relevant public health orders. The goal of any group discussing whether to re-open is to have a fully informed group conscience. Jim also mentioned that the State of Ohio may be coming out with guidance for small groups such as recovery groups.

OLD BUSINESS

Collections received during today's Assembly will be reported next month, and the Assembly will vote next month on how to direct any funds received online during the Assembly.

NEW BUSINESS

Tim DeRan, Chairman, Northwest Ohio/Southeastern Michigan Intergroup Association started a discussion about Area 55 posting on its website. Wendy Schimmoeller, GSR – Ottawa Open Discussion moved to have Area 55 post on its website any relevant guidelines from <http://coronavirus.ohio.gov>. The motion was seconded by Don Stenavage, GSR – New Beginning.

- George Calton, Area 55 Recording Secretary, moved to amend the motion to state "Area 55 may post coronavirus guidelines from the state of Ohio or Michigan, as long as a disclaimer is made on the website that this information is not an AA directive, but only to help each group have an informed conscience." The motion to amend was seconded by Wendy Schimmoeller, GSR – Ottawa Open Discussion. After discussion, Ron Schudel, Past Delegate – Area 55 Panel 48 moved to call the question/end debate, seconded by Chris Carson, Area 55 Treasurer. The Assembly voted 10 yes, 1 against, 0 abstention, to call the question – proceed to vote.
- The motion to *amend* to main motion (change the main motion) passed with a vote of 16 yes, 4 against, 0 abstentions.
- The amended motion passed the Assembly, with 15 yes, and 6 against. The amended motion of "Area 55 may post coronavirus guidelines from the state of Ohio or Michigan, as long as a disclaimer is made on the website that this information is not an AA directive, but only to help each group have an informed group conscience" passed.
- Rachel Watson, GSR – Trail Group, Marty Coombs, GSR – New Hope, and Ron Schudel, Past Delegate – Area 55 Panel 48, spoke in the minority opinion. After hearing the minority voice, John Carter, Past Delegate – Area 55 Panel 66 indicated that he would like to change his vote. In accordance with AA guidelines, the Assembly then took a vote to re-consider the action. The motion to reconsider passed, with 18 for, and 4 against, and 0 abstentions.
- The Assembly then re-voted on the amended motion, with 5 voting yes, 17 voting no, and 0 abstentions. The motion failed, and no Area 55 action will be taken on this issue.

Tim DeRan, Chairman – Northwest Ohio/Southeastern Michigan Intergroup Association, mentioned that there is a new group in District 4 called "In the Book." The group meets Mondays 5:30 p.m. at Bible Fellowship on Dorr Street, and has appointed a General Service Representative.

Discussion was held about a couple of groups with Zoom accounts that have expressed interest in donating that account to the Area to help with any Accessibilities, Shut-Ins, or Committees.

Rachel Watson, GSR – Trail Group, mentioned the importance of mailing out the minutes and treasurer's report before the July meeting.

Tarik Kadri, DCM – District 3, moved to have Unity Day information added to the Area 55 guidelines. The motion was seconded by Eva Slawson, GSR – Live & Let Live. The motion passed, with 19 voting yes, 1 voting no, and 0 abstentions. Unity Day will be included in the Area 55 Guidelines. The minority opinion was heard.

Tarik Kadri, DCM – District 3, moved to reduce the frequency of Area 55 General Assembly meetings to quarterly instead of monthly. The motion was seconded by Chris Carson, Treasurer – Area 55 Panel 70.

- Jim Snider, Delegate - Area 55 Panel 70, moved to table the motion until the Assembly's August meeting to give members time to seek input from their group conscience. The motion was seconded by George Calton, Recording Secretary – Area 55 Panel 70. The motion to table passed unanimously. The issue will be tabled until the August Assembly meeting.
